## **Completion of Placement**

Proteomics International Laboratories Ltd (Proteomics International; ASX: PIQ) advises that further to the ASX announcement of 23 October 2020, the Company has today completed the \$6.0 million placement to UK and Australian-based institutions, and sophisticated and professional investors (the "Placement").

The Company has issued 12,500,000 fully paid ordinary shares (**Shares**) at an issue price of \$0.48 per Share pursuant to the Placement. The Shares were issued utilising the Company's 15% placement capacity under Listing Rule 7.1.

Euroz Hartleys Securities Limited acted as Sole Lead Manager and Bookrunner to the Placement, and Candour Advisory acted as Corporate Advisor to the Placement.

An Appendix 2A applying for quotation of the Shares follows this announcement.

### **Secondary Trading Notice Pursuant to Paragraph 708A(5)(e) of the Corporations Act 2001 ("Act")**
