## **Exercise of Options**

Proteomics International Laboratories Ltd (Proteomics International; ASX: PIQ) advises that the Company has today issued 150,000 fully paid ordinary shares (**Shares**) upon the exercise of unquoted employee options exercisable at \$0.50 per option on or before 1 May 2023 raising \$75,000 before costs.
